

**PLEASE NOTE THE FOLLOWING:**

1. Many of our classes for Term III are offered as online courses. **There are the following limitations on online courses:**
  - a. Students in the **JD Program** are limited to 45 credits of online courses out of their 90 credits required for graduation.
  - b. Students in the **Dual JD Program** are limited to 30 credits of online courses out of their 60 Detroit Mercy Law credits required for graduation.
  - c. Students who have an F1 visa or are in the Dual JD Program are limited to one online course (up to 3 credits) per term.
2. Term III is a seven-week term that runs from May 28 to July 25, 2024. Because of the number of Monday holidays, students should take note of the rescheduled class times for courses that are offered on Mondays and Wednesdays.
3. Registration for clinics will occur after priority registration for other courses. Please make sure to consider whether the clinic requires specific days/times for clinical work in making your selections.
4. **Mediation Training** will be offered online during the first three weeks of the summer term as follows:  
Week One: Tuesday, May 28 – Thursday, May 30, 9:00 a.m. – 12:30 p.m.  
Week Two: Monday, June 3 – Thursday, June 6, 9:00 am – 12:30 p.m.  
Week Three: Monday, June 10 – Wednesday, June 12, 9:00 am – 12:30 p.m.  
Final Session: Saturday, June 15, 9:30 am – 3:30 pm
5. **Access to Justice Practicum:** The one-week expungement clinic will be offered during the summer term. There will be a 90-minute class on Thursday, May 30. The week that students will travel to participate in the clinic is still being worked out. This course will be limited to 6 students. Further information regarding the course and how to apply for it will be sent separately by Dean Schroeck. The application and registration for this course is similar to that of the clinics.
6. **Selected Topics in Immigration Law Seminar** will be offered to allow students to earn credits toward a concentration in Immigration Law.
7. **Children and the Law** is an online class. It will be part synchronous, with class meeting on Tuesdays and Thursdays, from 9:00 – 10:25 a.m., and part asynchronous. The final class may be in person, and the final presentations will be on Thursday, July 25, and this session may be in person. The course satisfies both the global and transnational distribution requirement and can also be used to earn credits toward a concentration in Family Law.

**Summer Term Policies:**

1. **Credit hour limit:** Students in the **JD** program may enroll a maximum of **nine (9)** credits in Term III. Students in the **Dual JD** program may enroll in a maximum of **ten (10)** credits in the Term III.
2. **Financial aid:** Students must enroll in a minimum of three (3) credits to be eligible for US Federal Financial Aid.
3. **Course cancellation:** Courses with an enrollment of less than ten (10) students (except the Clinics) are subject to cancellation.

**Summer Clinic Requirements:**

**Family Law Clinic:** In addition to class time, students must be available on Tuesdays from 10:00am to 3:30pm or 4:00pm, and Thursdays from 9:00am to 3:30pm or 4:00pm, to perform clinical hours at the William Booth Legal Aid Clinic located at 3737 Lawton St, Detroit, MI 48208. The clinic is a 5-minute drive from the law school and has parking available. Class meets during this time on Tuesday. Students must complete a minimum of 105 work hours.

**Criminal Trial Clinic:** Students must be available at least 12 hours per week from 8:30am to 12:30pm to be in court via Zoom at 36th District Court in Detroit. Students must be available on Thursdays from 8:30am to 12:30pm to appear in person at the 52nd-4 District Court, located at 520 W. Big Beaver Road, Troy, MI 48084. Students will also be required to do some clinical hours outside of class. Students must complete a minimum of 105 work hours.

**Pro Se Clinic:** The Pro Se Clinic is open Monday, Wednesday, and Friday from 1:00 to 5:00pm and is in Room 768 of the United States District Court, 231 W Lafayette Blvd, Detroit, MI 48226. Students must participate in three clinic triage meetings (1 of the 3 weekly triage sessions may be on zoom) to prepare for each Clinic Day from 12:30 to 1:00pm. Students must work in-person at the clinic at least two clinic days. Students will coordinate coverage of the clinic for all 3 days at the beginning of the semester. There will also be Clinic tasks outside of normal Clinic hours. Students must complete a minimum of 105 work hours.
