

## **IMPORTANT INFORMATION**

1. This is a draft schedule. There could be changes, although we will attempt to keep them to a minimum.
2. Students will be given the opportunity to preregister for clinics. All clinics have additional hour requirements beyond the class times, and some have specific time periods in which the work must be done. Please check the clinic information document sent from Director Nowak to learn of those requirements. **Registration for clinics will open May 27 and applications will be due May 30.** The clinic will email offers to students the end of the first week of June and acceptance of offers will be due June 9.
3. After registration for clinics occurs, 3Ls will be able to preregister for LFPs. The LFP form will be emailed to 3Ls on June 10 and will be due on June 12.
4. Priority for Fall 2025 (Term I) clinics and LFPs is given to those graduating in December. There will be sufficient clinical and LFP offerings in the Winter 2026 (Term II) to ensure that all graduating students satisfy the graduation requirements.
5. Registration for other courses will be July 7 – July 15. Dean Khan, the Registrar, will be emailing the specific dates for registration, which depend on the credit hours earned by students.
6. Please read the General Guidelines for Course Selection for the JD and Dual JD programs that accompany this schedule on the Law Registrar's website.
7. Please pay attention to prerequisites when registering. For example, Trial Practice requires students to have either taken Evidence or be taking Evidence in the same term as the Trial Practice Course. The Criminal Trial Clinic requires Evidence as a prerequisite.
8. There will be academic advising sessions on Zoom on May 27 at 1:00 pm (JD) and May 28 at 1:00 (Dual JD). Links will be sent via email and the sessions will be recorded. Deans Archerd (Academic Affairs) and Khan (Registrar) are also available for individual appointments, and Dual JD Director McCoy is available for individual appointments for students in the Dual JD program.
