### WORDMARK

The immediate recognition and overall visibility of Detroit Mercy Law Signature or Wordmark can be enhanced by maintaining an ample clear area, void of typography or other elements, around the perimeter of the Wordmark or Signature. This area is referred to as the “clear zone.”

Measure the height of the “D” in Detroit Mercy Law (X). A clear zone must be equal to or greater than X.

*A tight application clear zone can be used for applications with limited space. This clear zone must be equal to or greater than 1/2-X.*

Measure the height of the “Y” in Lawyer (Y). A clear zone must be equal to or greater than Y.

## LOGO

When used on its own, the minimum size is 3/8-inch wide.

### PREFERRED USE:

**BASKERVILLE**, a classic old-style serif typeface, is used for body text, but it can be used for headlines, initial caps and intro segments.

**FRUTIGER**, a clear and highly legible sans serif typeface, is used for headlines, initial caps and intro segments to text, but it can be used for body text as well.

### MICROSOFT OFFICE SUITE APPLICATIONS:

It is recommended that Arial (for Frutiger) and Times Roman (for Baskerville) are used for Microsoft Office Suite applications. These fonts are universally available and will provide Detroit Mercy Law with a seamless transition as the brand is used and implemented.
